3. This guarantee may be immediately enforced by Owner/Agent upon any default by Resident and an action against Guarantor may be brought at any time without first seeking recourse against Resident. (specifically including but not limited to actions for unlawful detainer or any other action that may be brought against any Resident bound by the lease agreement.

4. The insolvency of Resident or nonpayment of any sums due from Resident may be deemed a default giving rise to action by Owner/Agent against Guarantor.

5. If any legal actions or other proceedings are brought by any party to enforce any part of this Guarantee, the prevailing party shall be entitled to reasonable attorney's fees and costs incurred.

6. This Guarantee does not confer a right to possession of the premises by Guarantor, and Owner/Agent is not required to serve Guarantor with any notices to terminate or to perform Covenants, including for payment of the rent, prior to Owner/Agent proceeding against Guarantor For Guarantor's obligations under the terms of the Lease Agreement.

7. Unless released in writing by Owner/Agent, Guarantor shall remain obligated for the terms of this Guarantee for the entire period of the tenancy as provided by the Lease Agreement and For any extensions granted pursuant thereto.
